# **Key Issues Discussed**

- 1. Health and educational services should be free or low-cost and provided by educators and healthcare providers, who are non-judgmental;
- 2. Healthcare workers are trained in providing age-appropriate health information and welcoming towards adolescents' health and contraceptive needs;
- 3. Availability of preventive services such as birth-control, psychological counseling, and/or testing for sexually transmitted diseases.
- 4. Ensure the health, safety and well-being of all women- and men-workers.
- 5. Promote education, training and professional development for women of all ages.
- 6. Measure and publicly report on progress to achieve gender equality at regional, national and international levels.
- 7. Building the evidence-base, mainly community-based research that is affordable and has immediate implications for programs and local partners.
- 8. Provide strong and coherent leadership in support of Member States' priorities and efforts, building effective partnership and civil society and other relevant actors.

# **Key Recommendations for Action**

- Inclusion and equity in and through education sector: it is the cornerstone of a transformative education agenda.
- Access: motivated by our significant achievements in expanding access to evidencebased health information on our global platform for the last two decades – we will ensure that the provision of access to the Least Developed Countries (LDCs) is free, publiclyprivately funded, equitable quality primary and secondary education, of which at least 10 years are compulsory, leading to relevant learning outcomes.
- Gender Equality: We are committed to supporting gender-sensitive policies, planning and learning environments; mainstreaming gender issues in teacher training and curricula; and eliminating gender-based discrimination and violence in schools.
- Quality Education: Our resource and continuing education projects and programs ensures quality education, that fosters creativity and knowledge, and ensures the acquisition of the foundational skills of literacy and numeracy as well as analytical skills, problem solving, and other high-level cognitive, interpersonal and social skills. In 2021, WHEC launched a new initiative for SDGs 3, 4, and 5: *Learning Life Lessons Series.* These so-called Life Lessons, are very popular, These programs are helping schools, universities, teachers, students, and administrators to plan and develop *Health Promoting Schools.* We encourage institutions to use this as a resource to increase engagement, learning and good mental health.
- Life-long Learning Opportunities: We commit to promoting quality life-long learning opportunities for all, in all settings and at all levels of education.

#### **Objectives of WHEC's Initiatives**

Quality education and providing timely evidence-based information in health-sector, which is accessible to all, and reliable disaggregated data, will be needed to help with the measurements of progress of all Sustainable Development Goals (SDGs), especially in health and education sectors. To ensure that no one is left behind, open science, artificial intelligence (AI) and Big Data Management will be the key to the decision-making process, in the future. The utilization of AI and Big Data can be capitalized upon through the construction of dynamic, robust and inclusive public data ecosystems, via UN funded data co-operatives and algorithmic accountability programs.
