- Glossary
- Support Services & Resources (if available).

## **General Considerations:**

1. When formatting the text, please use bold text for demarcations instead of italics, or other special formatting. Tables can be used in the text but are discouraged because they take a long time to download and build. In general, only use tables when words cannot explain something clearly.
2. If there are any obvious links in the text, include a message in parentheses. Each condition section should include a list of links within the text; the links can be to other pages in other condition sections or glossary terms.
3. We plan to keep our site as educational as possible. We do not want to fill up sections with treatment advertisements. All specific drug company information will end up in a pop up window. Please keep this in mind when writing the treatment sections. Write as much as you like concerning treatment options, but please resist pushing any one treatment or drug. Obviously, if there is only one company that makes a certain treatment, it is appropriate to discuss it.
4. We prefer an interesting, narrative style to a scientific or academic one.

As your content comes into our office, we will edit and possibly send the content to our medical editors. We will ask you to do a final check for medical accuracy. If you have any questions or concerns, please do not hesitate to contact us. Authors are responsible for the accuracy of data and the correctness of references.
